

# 2011 Fun on Foster Vendor Registration Form



**VENDORS** are needed for **Fun on Foster** on Saturday, September 24, 2011, 10AM-5PM.

Vendor areas will be primarily in Laurelwood Park at SE 63<sup>rd</sup> and Foster. Vendors will receive a 10-by-10-foot space for the day and must bring their own canopy, table, chairs and trash containers. There will also be sidewalk setups for artists involved in the Foster Art walk. An Eco-shuttle will travel the length of the fair stopping at all Fun on Foster activities.

Setup starts at 8 am and fairgoers begin to arrive around 10 am. Please let us know if you plan to leave before 5 PM, otherwise we expect your booth to remain open until the end of the event. We ask that you remove your own trash/garbage.

No food items can be sold without special approval. Vendors are responsible for their own items and sales.

To sign up, fill out this form & enclose payment. A confirmation email will be sent or a phone call will confirm Locations assigned only after payment & registration form are received. **Vendors must sign liability waiver.**
